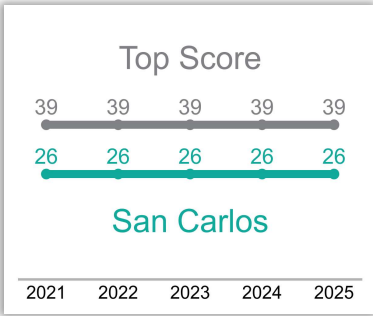


# Cannabis Policy

## 2025 DELIVERY SCORECARD

San Carlos

This scorecard analyzes local cannabis ordinances passed prior to January 1, 2025, in each California city or county that legalized retail sales only by delivery, to assess policies in effect going into 2024. It evaluates to what extent potential best practices were adopted to protect youth, reduce problem cannabis use and promote social equity beyond those already in state law. Scores fall into six public health and equity focused categories for a total maximum of 100 points.
